uccessful writ of habeas corpus in relation to Mr Remice's remand into custody. Leading authority re: prosecution bail appeal and detention under .128A(2) Magistrates' Court Act 1980. Divisional Court found that Mr Remice had been unlawfully remanded by Woolwich Crown Court.
